**Community Services Block Grant (CSBG):**

The State Department of Social Services, Community Services Block Grant (CSBG) provides STOP with its administrative (core) funding. This grant also provided one-time crisis intervention for 1,494 individuals and 1,028 families who experienced financial difficulty in meeting their basic needs for the payment of rent/mortgage, employment and training transportation services, emergency housing assistance and utility payments during this fiscal year.

**Weatherization Assistance Program (WAP):**

STOP's Weatherization Assistance Program (WAP) provides funds to reduce the heating and cooling costs for low and moderate income families that will ensure their health and safety. Services are available for low income and moderate income households, particularly for the elderly, individuals with disabilities and families with children. STOP's WAP weatherized the homes of 452 families and 1,314 individuals during this fiscal year.

**Supportive Services for Veterans Families (SSVF):**

STOP's Vet-Re-Connect Program promotes a "Housing First" model through assistance with rental payments, moving costs, transportation, child care, , general housing and or emergency housing, utility fee payment, security and utility deposit. SSVF is a rapid-re-housing program that provides intensive case management assisting Veterans with connecting to their Veteran Benefits as well as mainstream resources. Over 136 Veterans received housing stability services during this fiscal year.
